**MINUTES OF MONTHLY MEETING OF EDENDERRY TOWN COUNCIL

The meeting commenced with a minute silence as a mark of respect for all deceased in the last month in Edenderry and for John Egan who died recently in a tragic accident in Ghana.

Cllr Murrin and all members congratulated the Edenderry Senior Football team on winning the county final last Sunday against Clara. All players, management team and supporters were complimented for their efforts and for lifting the spirits of the town. Peter Brady, Finbarr Cullen and Kevin Guing were given special mention. It was proposed by Cllr Foley and seconded by Cllr O'Neill to hold a civic reception for the team, details of which to be discussed after the meeting. It was also proposed by the above to write a letter of congratulations to the secretary of the club.

Cllr McDonnell asked that a statement Cllr Foley made re income from parachute club at the last monthly meeting be withdrawn and that the facts were incorrect. Cllr Foley said that the statement was withdrawn at the last meeting.

It was proposed by Cllr Foley and seconded by Cllr O'Neill to support notice of motion from Carrick on Suir TC re waiver scheme for refuse collection. Monaghan TC notice of motion re criminal justice bill 2011 was noted as read.
