



**PLANNING AND DEVELOPMENT ACT, 2000, AS AMENDED.
PART 8 OF THE PLANNING AND DEVELOPMENT REGULATIONS,
2001, AS AMENDED.**

Notice is hereby given that Offaly County Council proposes to carry out development at Circular Road, Daingean, County Offaly.

The development will consist of:

The demolition of the existing dwelling and construction of 10 no. social housing units; 1 no. 4-bed semi-detached single storey dwelling & 9 no. 2-bed terrace/semi-detached single storey units, along with associated site development works.

The development has been the subject of an Appropriate Assessment screening in accordance with the EU Habitats Directive and the Planning and Development Act 2000 as amended. The Appropriate Assessment screening concluded that the proposed development would not be likely to give rise to significant or indeterminate impacts on any European site.

Offaly County Council has carried out a preliminary examination of the nature, size and location of the proposed development and has determined that the proposed development will not have significant effects on the environment and does not require an Environmental Impact Assessment.

Any person may, within 4 weeks beginning on **Tuesday 17th December 2024**, apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.

For a period of **4 (four) weeks**, beginning on **Tuesday 17th December 2024**, plans and particulars of the proposed development will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy during office hours at the offices of Offaly County Council, Áras an Chontae, Charleville Road, Tullamore, County Offaly, R35 F893.

For a period of **6 (six) weeks**, beginning on **Tuesday 17th December 2024**, submissions or observations with respect to the proposed development dealing with the proper planning and sustainable development of the area in which the development would be situated, may be made in writing to The Director of Services, Housing Section, Offaly County Council, Áras an Chontae, Charleville Road, Tullamore, County Offaly, R35 F893.

Tugtar fógra leis seo go bhfuil sé i gceist ag Comhairle Contae Uíbh Fhailí forbraíocht a dhéanamh ag an gCuarbhóthar, an Daingean, Contae Uíbh Fhailí.

Is éard a bheidh i gceist leis an bhforbraíocht sin:

An teaghais atá ann faoi láthair a scartáil agus 10 dteach shóisialta nua a thógáil; teach 4-leaba leathscioite aon stóir amháin agus 9 n-aonad 2-leaba sraithe/leathscioite aon stóir, chomh maith leis na hoibreacha forbartha lena mbaineann ag an suíomh.

Tá an fhorbraíocht faoi réir Scagadh le haghaidh Measúnacht Chúí i gcomhréir leis an Treoir maidir le Gnáthóga ón Aontas Eorpach, 1992 agus an Acht um Pleanáil agus Forbairt, 2000, mar a leasaíodh. Ba é conclúid an Scagtha le haghaidh Measúnacht Chúí nach dóchúil go mbeidh tionchar mór ná dochinntithe ar aon suíomh Eorpach de bharr na forbraíochta atá beartaithe.

Tá réamhscrúdú déanta ag Comhairle Contae Uíbh Fhailí ar chineál, méad agus suíomh na forbraíochta atá beartaithe agus tá molta aici nach mbeidh mórthionchar ag an bhforbraíocht chéanna ar an gcomhshaol agus, dá bharr sin, nach mbeidh gá le Measúnacht Tionchair Timpeallachta.
