



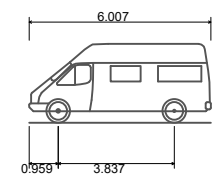

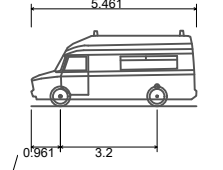

 VEHICLE PROGRESSING IN A FORWARD GEAR

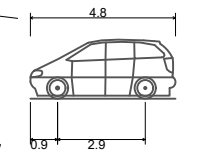
