Climate Action

On 9th December 2024 Peter Burke, Minister of Enterprise. Trade and Employment launched a new EnergyCloud project in Offaly with Amazon Web Services (AWS) and Offaly County Council. The Climate Action initiative as contained within the Offaly County Council Climate Action Plan 2024-2029, was announced as part of an ongoing collaboration between not-for-profit EnergyCloud Ireland and Amazon Web Services (AWS). This program will enable 300 families in the Midlands to receive free tanks of hot water from surplus renewable energy via the installation of an EnergyCloud enabled smart device. The device uses surplus renewable energy, which would otherwise be wasted to heat immersion tanks.

The first homes will be delivered in collaboration with Offaly County Council. Cathaoirleach of Offaly County Council, Cllr Audrey Hennessy Kennedy said 'Offaly County Council are delighted to be part of this EnergyCloud Initiative, which connects the innovative technologies in our Tullamore Decarbonisation Zone with our stated aims in our Climate Action Plan to use surplus renewable energy to help those in energy poverty across the whole county'.

Litter Management - Engagement with Local Voluntary Groups on Litter Management

There were 17 litter picks carried out by local voluntary groups facilitated by Offaly County Council in the month of December 2024. A total of 1,140kg of litter was collected and processed. This brings the overall tonnage of litter collected from January to December to 33 tonnes.

A total of 312 litter collections by local voluntary groups took place in 2024, supported by Offaly County Council's Environment Section. During the month of January, this information will be promoted on social media to thank the public for all their hard work and co-operation in managing litter in their area.

Burial Grounds - Cemetery Committees

We are currently working with 20 cemetery committees across the County including two new committees that were formed in 2024. We have paid out 27 grants over the course of 2024 totalling €47,334.00 targeted at supporting the dayto-day maintenance of our cemeteries. This funding has been used to assist in the delivery of the dashing of cemetery walls, removal of old trees and replacement with a new native based hedge and the purchase of equipment. The Climate Action, Environment and Rural Water section welcome engagement from groups that are currently maintaining their local cemetery or planning on forming a committee to do so with the view to potential grant funding in the future.

St. Mary's Cemetery, Edenderry

The main contract work for the extension to St. Mary's cemetery has been completed and will provide an extra 300 burial spaces. The completion of the remaining landscaping works will take place over the coming months.

RURAL WATER SERVICES - Capital

Applications for capital funding from the Multi-Annual Rural Water Programme 2024 to 2026 (MARWP) were submitted to the Rural Water Unit, Dept of Housing, in April 2024. The Rural Water Unit have recently announced their decision (November 2024) on a portion of the grants and we have advised the Group Water Schemes of those decisions.

All projects that were submitted were reviewed and passed Stage 1 of the application process. Stage 2 of the application process involves consideration by the RWU's Expert Panel for consideration. We are currently awaiting the expert panel's decision on the remaining grants, predominately made up of measures relating to water conservation, leakage reduction and prevention.

Subsidies

Offaly County Council paid a total of €1,069,594.00 in subsidy support to 15 group water schemes IN 2024.

Veterinary - Control of Dogs

In 2024 we cared for over 214 dogs in the dog shelter. 15% of these dogs were reclaimed by their owners, 15% were rehomed by the Care of Dogs Team and the remaining 70% were rehomed through animal rescue charities.

The Control of Dogs team has also dealt with 90 complaints in 2024, including dog licence issues, straying dogs and dealing with dangerous dogs. The team has also assisted An Garda Siochana with regard to the delivery of their services.

Dog Shelter

In late 2023 we received notification of grant funding from the Department of Rural and Community Development to assist with the costs associated with the upgrade works to the dog shelter through the Department's Dog Control Support Initiative. The funding has been used for –

Replacement of wooden and steel doors in the Dog Shelter





Improving site security and public safety by erecting palisade fencing and extending the public pathway and fitting pvc panels to viewing area





Increasing the time that the dogs can have outdoor play by subdividing the playing areas with mesh fencing



Upgrades to 3 whelping areas to accommodate bitches and pups in more suitable accommodation, including heat lamps, whelping crates and a pvc finish





Improved vet's room and isolation area and new water and wastewater supplies





Control of Horses

Offaly County Council processed 15 complaints in 2024 with no associated animal seizures

Veterinary Inspections

From 1st January 2025, the Food Business and Veterinary Inspection function will be transferring from Local Authorities to the Department of Agriculture, Food and the Marine. Offaly County Council's Shared Service Agreement for Veterinary Services with Westmeath County Council ceased on the 31/12/24.

TRANSPORTATION

Corporate Fleet Management

Offaly County Council received delivery of its 3rd velocity patcher in December. The addition of this 3rd vehicle means that each Municipal District now has its own assigned velocity patcher. The deployment of this vehicle will further strengthen and improve our road maintenance approach while also providing additional Health and Safety and Carbon Reduction improvements.



Birr North Distributor Road

Offaly County Council signed contracts for the construction of the Birr North Distributor Road on the 11th of December 2024. The successful contractor Kenny Plant and Civils Itd are scheduled to commence works onsite in January of 2025 with a proposed 7-month construction timeline.



This scheme will provide a strategically important new section of road and active travel infrastructure linking the N52 and the R439 Birr to Banagher that will

- relieve congestion in Birr Town by providing an alternative to the existing route through the town, assist in the decarbonisation of the town centre and further improve air quality
- provide better access to the National Road Network and enhances both Rural and Regional Connectivity,
- open up zoned development lands and promote compact growth and permeability
- provide improved access to both primary and secondary schools within the vicinity of the scheme through the provision the provision of Green, Safe, Sustainable cycling and walking infrastructure
- assist in promoting the tourism potential offered by Birr's historic and unique Georgian town centre.

Winter Service Plan 2024/2025

Our winter Service Plan commenced in October 2024. This service is managed by the Roads Department and the service is delivered from the Tullamore Machinery Yard and Birr Depot. There are 4 duty Engineers rostered across the season who asses real time data from the Road Networks in order to establish whether treatment is required and the associated rate of spread of rock salt.

R400 Peat Pilot

The R400 Peat Pilot project was opened to live traffic on Friday the 20th of December and provides approximately 1.8km of fully reconstructed Regional Road Network across Peatlands. Phase 2 of the Peat Pilot will commence onsite in early Q3 of 2025 subject to Department of Transport approvals.

Housing Update

- There are 552 on the Social Housing Support List at the end of December 2024.
- A further 473 active tenancies are currently being supported under the Housing Assistance Payments (HAP) Scheme, 6 signed up for HAP and 6 exited from HAP in December.
- At the end of December 40 single people and 15 couples/families were being supported in emergency accommodation.
- Number of maintenance requests received for month of December was 356.
- Total of housing stock at end of December was 2217.
- Social Housing Assessments (SSHA) 2024 is complete. All relevant approved applicants on Offaly County Council's Social Housing Support List, using the current address provided by the applicant were written to and completed forms were

due for return by **Friday, 30th August 2024**. The summary of needs has been completed and returned to the Dept of Housing, Local Government and Heritage.



Local Community Development Committee



Offaly LCDC held its monthly meeting on 12th December 2024. Agenda items included the LECP

Implementation Plan 2024-2025, Dormant Accounts Fund 2024 Allocation to support LGBTI+ Community Organisations, Healthy Offaly Projects Update, LEADER Programme 2023-2027 update (OLDC).

The Schedule of Meetings for 2025 was agreed and funding opportunities available to communities and individuals were detailed to members.

Community Recognition Fund 2024 (Window 3)

A fund of €300,542 was launched on 16th December 2024 under the final window of the Community Recognition Fund 2024. Applications must be submitted online by the deadline of **4pm on Friday**, **10th January 2025.** Full details are available at www.offaly.ie/community-recognitionfund-2024-window-3/. All PPN registered groups have been informed of the fund. The minimum level of funding for an individual project under this fund is €50,000.

The Community Recognition Fund was first introduced in 2023 to recognise the huge efforts made by communities in welcoming and hosting significant numbers of arrivals from Ukraine and other countries. Through the 2023 allocation. funding of €636,206 was allocated for some 27 projects in Offaly. Based on the continued impacts on communities, the Department of Rural and Community Development allocated further а

€1,055,308 to Offaly under the Community Recognition Fund 2024.

Of this fund, €702,000 was allocated in 2024 to 11 projects under Window 1 in the following locations: Tullamore (4), Birr (2), Banagher (3), Edenderry (1), Geashill (1). Under Window 3 (this call), proposals from the following areas will be prioritised:

- Portarlington
- Clara
- Daingean

Funding under Window 2 has been combined with Window 3 in the amount of the remaining €300,542 which is being allocated in January 2025. Priority will be given to projects which are in towns with significant numbers of new arrivals and to communities that have not yet received support via the Window 1 allocation. The applications will be assessed by an evaluation committee and shortlisted.

These shortlisted applications will be submitted to the Department of Rural and Community Development at the end of January 2025 for their approval. We anticipate that the Department will notify us of the successful applications in March / April 2025 and we will contact successful projects then. All approved projects under CRF 2024 must be completed no later than 1st October 2026.

Public Participation Network

Policy and Social Inclusion were the main focus areas for Offaly PPN in December.



Funding stream information was presented to the LCDC membership at the

December meeting and the information distributed via email to the LCDC members.

The Midlands PPN Region was represented by Bridie & Linda Dowling at the National Civic Forum for dialogue between the State and the Community & Voluntary Sector, which took place at Dublin Castle on Wednesday, 4th December 2024.

The Theme: "Joint Delivery for Better Outcomes. This event provided an opportunity for the Community and DRCD sections to engage on opportunities and showcase projects undertaken in collaboration with a number of stakeholders.



Offaly PPN held its end of year Secretariat meeting and Christmas Dinner in The County Arms Hotel Birr on December 11th 2024. Discussions took place

on the Key actions for the 2025 PPN Workplan. These include high focus on the Secretariat as three long standing members will be stepping down in 2025 and work will need to happen early in the year on replacements. Training for the Secretariat and the range of new PPN Reps on Boards and Committees including the SPC is a priority for 2025.

Offaly PPN attended the Traveller Integration event in the Hazel Hub Tullamore. The focus was on Health and



Wellbeing supports for the Traveller Community. A range of agencies and support services were in attendance. The PPN also attended a Traveller Cultural Heritage event in Tullamore Library.



The Older Persons Christmas Party was held in Tullamore on Dec 10th. This is an annual collaboration between the PPN, The Gardai, OLDC and Tullamore Credit Union.



Great support from Transition Students from Tullamore schools ensured the afternoon was a great success.

The final Newsletter and funding stream information of the year were distributed to all members in December.

ARTS OFFICE The 2025 Youth Arts Commissions - Deadline for Proposals February 2025



The 2025 Youth Arts Commission call-out is currently advertised with a deadline in February 2025. The Youth Arts Commissions enables artists to work with youth groups and communities to develop projects that will enable engagement between professional artists and young people (13+), facilitated by youth organisations, youth leaders and schools. The goal being to build secure relationships with relevant partners for the development of Youth Arts in the county. The voice of the young people is a priority for this programme.

Mini Movies Programme 2025 – Deadline for Proposals January 2025

Offaly County Council Arts Office is currently seeking proposals/quotations from Professional Film Facilitators for the delivery of a six-day programme of film workshops to schools in Offaly. The programme will consider either animated or live action. Mini Movies are both action and stop motion short movies created by children and young people.

Since 2012 Offaly County Council Arts Office has funded a professional film artist to work with three schools in Offaly over several days. The result are mini movies which are then screened at the OFFline Film Festival in Birr. The Mini Movies are can also be viewed on <u>Offaly Arts Youtube</u>. This year we have selected and contacted 3 rural schools: Rhode (NS) Kilcormac College, (secondary) and Geashill (NS) as potential project participants.

FilmOffaly

For The Cure

Post-production on **For The Cure** (Our Film Award Winner for 2024) has been taking place. We are expecting to see a first edit for feedback when we return to the office in the New Year.

FilmOffaly 2025 Award

At the end of January we will be launching the FilmOffaly Short Film Award for 2025. As part of this we are holding a launch night at Esker Arts, Tullamore on 29th January. Since its inception in 2009 the award has



fostered creative

filmmaking and compelling cinematic storytelling – all shot entirely in Offaly. During the evening there will be screenings of previous award winners, many of which have gone on to win accolades on the film festival circuit. There will also be an opportunity to hear more about the award, and a chance to network afterwards. We're especially keen on organising regular meetups for the Offaly filmmaking community and hope this will be the first of such events.

We also sent out a questionnaire to a selection of previous award winners to get their feedback. Those who got back to us shared some good suggestions for how to improve the award. We will be looking at the feedback and seeing what we can incorporate into this year's plans.

FOCUS 2024

We attended FOCUS 2024 at the Business Design Centre in London on 10 & 11th December. FOCUS is a trade event for anyone involved in the creation, production and promotion of on-screen entertainment with guest speakers, panels and presentations.



We were invited to attend as part of Screen Ireland's delegation (pictured). We were there to encourage and pitch to screen professionals to base their projects in Ireland (in our case hopefully Offaly!)

This was a valuable opportunity to meet and learn from fellow film offices in Ireland, and other commissions based around the world. We came away from the festival having had lots of conversations, a few potential leads and some good marketing ideas from other film commissions.

Although the main purpose was to network with fellow screen professionals, our attendance there helped us to achieve a valuable goal in making sure all the forward-facing elements of FilmOffaly (such as website and social media) were all thoroughly up to date.

Funding Opportunities

Offaly County Council Arts Office has opened its application process for a variety of grants offered to professional artists, communities, and festivals for 2025.



Offaly County Council Arts Office offers a number of grant schemes to assist in the development and promotion of the Arts across the county. The grants include the Arts Acts Grants 2025, the Festival Arts Scheme 2025 and the Professional Artists Support Award 2025.

The Arts Acts Grants are community based and designed to support Offaly voluntary arts organisations, schools, drama & musical groups, town bands, voluntary community groups intending to host arts events, performances, or projects taking place in Offaly in 2025.

The Festival Arts Scheme is designed for festivals taking place in Offaly in 2025 that

are either dedicated arts festivals or have a strong professional arts element to the festival.

The Professional Artist Support Award offers a support scheme for professional artists in developing their arts practice over a number of categories.


Business Development Report – OFFLine Animation Residency

The OFFline Animation Residency in Birr is a unique support for animation artists in Ireland. It was established and launched in 2017, and the first Residency commenced 2018. The Residency offers the in opportunity to spend a six-month period in Birr and is managed by OFFline Film Festival which was established in 2010. The Residency also includes opportunities for mentoring and networking, and opportunities for engaging with the local particularly with community, young people. Following its successful delivery between 2017 and 2022, it is a timely moment to develop a business plan and build on the strengths and learnings from the programme so far. A call out for tender to conduct research and compile business development report has been advertised and a successful contractor will be selected in January 2025.

Creative Places Edenderry

In November 2024 Creative Places Edenderry published its Three Year Report which reflects on the first three years of the Creative Places, Edenderry the theme of Project, which Connect, was Cultivate. Celebrate. Creative Places, Edenderry



works with people of all ages and

backgrounds to create a richer, more inclusive, and more cohesive creative community in the town and surrounding areas. Over the course of the first three years of the project (2021-2024) there have been creative opportunities for professional artists, non-professional artists, community groups, and individuals.

Creative Places, Edenderry, a project funded by the Arts Council, led by Creative Lives in partnership with Offaly County Council Arts Office and Edenderry Municipal District was awarded a 4th year of funding by the Arts Council and goes from strength the strength hosting an array of different arts-based activities, workshops and events in a wide range of art forms including Visual Arts, Music, Poetry, Playwriting, Creative Movement; Dance; Ceramics; Drama; Radio, Photography.

INFRASTUCTURE PROJECTS Public Art Commission: Esker Arts in collaboration with Lough Boora



Council Arts Office announced a call to professional artists for proposals for a public art commission for Esker Arts, in conjunction with Lough Boora Sculpture Park. Deadline for the

first stage submission is 3 January 2025 Offaly's Arts Office are seeking proposals that will demonstrate how artist(s) will work collaboratively with communities of both Esker Arts and Lough Boora Sculpture Park. Offaly County Council is looking for an imaginative project that demonstrates an innovative approach, enabling creative dialogue between stakeholders and communities, while representing best practice within the realm of public art practice.

Lough Boora Sculpture Park

The Arts Office funded by Creative Ireland and supported by Bord na Móna have commissioned a new maintenance programme for Lough Boora Sculpture Park to take place through 2024-2025. Artist Michael Burke, Sculpture Works, has carried out a review and report and works having been taking place throughout the summer.

Edenderry Library and Arts Base

The Arts Office continues to work in close collaboration with the county librarian in the development of plans for a multipurpose Arts space and Artist's Studios to be incorporated into the planning of the new library for Edenderry including the audience and participant development as part of the Creative Places Edenderry project.

HEALTHY OFFALY



Work continued in December in contacting all Healthy Offaly implementing partners to submit their

financial and progress report information. Once all financial and progress reporting information has been received, the task will commence on uploading the documents and expenditure claims to Pobal online portal. This is a timeconsuming process and will take several weeks in January to complete. Another item of note was an update given to the Offaly LCDC and the progress of year 2 of Healthy Offaly's actions.

The Healthy Ireland Coordinator, Dermot Egan requested approval from the LCDC to proceed with a '*No Smoking*' initiative that has shown to be successful nationally. It is well known that there is a growing momentum to tackle the habits of smoking and vaping in Ireland. Statistics from the HSE show that in Ireland just over 3 in 20 people smoke. Tobacco Free Ireland aims to reduce this to 1 in 20 by 2025. Two of the main goals in this plan are to:

- protect children and make smoking seem less normal
- offer help to quit tobacco use.

In May 2018, HSE's Tobacco Free Ireland (TFI) Programme held a conference at Farmleigh House, Co. Dublin for World No Tobacco Day. It had a variety of external partner agencies who are advocates for tobacco control. They held workshops to figure out how partner agencies can discourage tobacco use for the next generation. 'Not Around Us' was one of these projects. 'Not Around Us is about promoting an environment where it is easier for those who smoke and vape to quit, and stay quit, and to help denormalise smoking/vaping for the next generation. The purpose of the campaign is:

- Assisting in helping to protect children and young people from second-hand smoke exposure.
- Contribute to the de-normalisation of smoking and vaping for children and young people.
- Reduce the environmental nuisance, cost of cleaning and damage that discarded tobacco products create.
- Signpost to HSE QUIT services.

The project has grown exponentially in the intervening years with Clare, Wexford, Limerick, Meath and Galway Local Authorities rolling out the campaign in their counties. Healthy Offaly would like to spearhead the rollout of the '*Not Around Us*' campaign in the county.

As the primary focus of the campaign is awareness the installation of '*Not Around Us'* signage in key targeted areas where adult and children congregate would be a critical component of the project. From fact-finding discussions had with Healthy Ireland Coordinator counterparts in other local authorities, it is envisaged the project would take place in three stages. Specially branded 'No Smoking/Vaping' signage with relevant QR codes would be installed in playgrounds in year 1, Sports Clubs in Year 2 and Schools and Youth Facilities in year 3. A working group would first have to be formed with key HSE, LOETB, Healthy Offaly Offalv and County Council Environment Section and Municipal District personnel. It is recommend setting aside funding of €5,000 for year 1 of the project. The Healthy Ireland Coordinator will work closely with our HSE Healthy Offaly Subcommittee partners. The bulk of the work in year 1 is the working group identifying the playgrounds to install the signage and to procure and install the signs.

A second proposal put to the LCDC was a request for approval for a new Healthy Offaly action whereby а 2024 implementing partner, Offaly Athletics would receive an award of €11,000 to roll out fully supervised and coached couch to 5k programmes for 10 weeks early in the new year to 10 athletic clubs in Offaly. The twice weekly sessions monitored by club coaches will target the exact demographic of persons exhibiting sedentary behaviours and those highlighted during our consultation exercise over two years ago at the outset of Round 4. Couch to 5K programmes have been listed among the examples of best practice to encourage an increase in physical activity in the WHO's Global Action Plan on Physical Activity (GAPPA).
