2. Election of Cathaoirleach

Cllr. Fitzpatrick invited nominations for the position of Cathaoirleach.

Cllr. F. Moran nominated Cllr. T. McCormack, as Cathaoirleach seconded by Cllr. O. Bryant.

Cllr L. Quinn nominated Cllr. J. Clendenen, as Cathaoirleach, seconded by Cllr. N. Cribbin

There being two nominees, the Meeting Administrator called a vote.

The Meeting Administrator declared that Cllr. Tony McCormack was elected Cathaoirleach of Offaly County Council.

Cllr. McCormack took the Chair.

The Cathaoirleach addressed the meeting, he thanked his proposer and seconder and the other members for supporting his nomination as Cathaoirleach. He said that he was greatly honoured to be elected as Cathaoirleach of the County Council. He thanked his family and supporters for their tireless efforts during the election campaign.

He outlined his priorities for the coming year. He stated that he would continue the campaign to have the N52 upgraded to help relieve the traffic speed and safety problems affecting the people of Durrow. He noted that the County needed new industrial parks to help attract international businesses and employment for the County. He advised that he would be meeting with the IDA to see how the Council could help address this need. He stated that he would be meeting with the business leaders in the county to explore ways that the Council could assist them in developing their businesses.

He stated that he would support the vulnerable of our society and hoped that the Council could increase its funding to the Disabled Persons Grant schemes and shorten the timeframes for the delivery of the supports under these schemes. He stated that he would support the Housing section in addressing issues of Anti-Social Behaviour and help ensure that Housing Tenancy Rules would be adhered too. He stated that during his term as Cathaoirleach he intended to address the issue of traffic calming in housing estates in the county.

3. Election of Leas-Chathaoirleach

The Cathaoirleach invited nominations for the position of Leas-Chathaoirleach.

Local Community Safety Partnership (LCSP) / Joint Policing Committee (JPC)

Ms. Giles advised the meeting that this new committee replaced the Joint Policing Committee (JPC) and was established under the *Policing, Security and Community Safety Act 2024*. She advised that expressions of interest for the role of independent Chairperson of the LCSP would be sought in the coming weeks. She noted that the Minister, having consulted with the other relevant Ministers, shall make regulations concerning the establishment and operation on LCSP's. She advised that the Council are awaiting the adoption of the regulations. On receipt of these, nominations to the LCSP will be brought back for consideration by the members, at a future meeting of Offaly County Council.

Each Partnership will have a maximum of 30 members, with 20 specified in regulations and the remaining 10 appointed by the Chairperson in consultation with the Partnership. Membership of the LCSPs will include residents, community representatives, local councillors, business and education representatives, and relevant public services such as the HSE, Tusla, An Garda Síochána, and the local authority

7. Induction Training for new Elected Members

Cllr. McCormack, Cathaoirleach informed the members that the Association of Irish Local Government (AILG) are organising a series of six weekly online webinars commencing on Friday, 28th June, and continuing every Friday until 2nd August 2024 and an in-person induction training module scheduled for 11th and 13th July. The details will be made available to all elected members.

He also reminded the members that an Information / Briefing meeting, for all Elected Members, was scheduled for 10.00 am on Monday 24th June 2024, in the Council Chamber, Áras an Chontae.

8. Appointment of Nominated Members to Witness Affixing of Official Seal

He noted that the outgoing Council had considered this issue at their last meeting. He noted that the Chief Executive and the Management Team had commenced the development of a policy and programme based on these discussions and following on from the meetings with Minister's Ryan and Burke. He agreed that that this item would be included on the Agenda for the first meeting of the CPG, scheduled for Monday 8th July 2024.
