#### **Matters Arising**

The members requested Director of Services Mr. T. Shanahan to contact TII and express dissatisfaction with respect to the delayed Preferred Route for the N52 Kilbeggan Link. The members outlined Offaly County Council procured the Preferred Route by Public Consultation and as a result the final Route Option report should be published as planning permission continues to be restricted until the route is chosen.

Mr. T. Shanahan advised correspondence has issued to TII however, in the interest of completeness it is necessary the report be revised.

The members further requested the link from Tullamore to Portlaoise and Tullamore to the motorway needs to be addressed.
