2. Draft Budgetary Plan 2021 – Consideration of the amount of General Municipal Allocation

Mr. T. Shanahan, DOS presented the Municipal District Allocation for Tullamore, as circulated to the members. Mr. T. Shanahan updated the members and advised the Chief Executive was proposing a General Municipal Allocation of €177,000, allocation for Tullamore MD in the Draft Budget 2022 to be considered at OCC's Statutory Budgetary Meeting.

Following discussions, Cllr. F. Moran proposed seeking an additional €100,000 in 2022, which was supported by the members.

3. Regeneration

The members welcomed the report as presented by Mr. John Connelly raising a number of queries including Brocca Rd, lights and pedestrian crossing on Collins Lane; Ballycumber Phase II; final phase of path in Clara Bog; pedestrian crossing at Westwood Grove; Silverdale; project for Brosna River; condition of derelict house on Church St; timeline for Millennium Sq.; outdoor dining on Kyran St; bus stop on Columcille St; buses on Henry St; TVR Mountbolus; parking of buses.

Mr. J. Connelly responded to the queries raised.

Ms. B. Corbet advised the members in relation to the upcoming Halloween event in Lloyd Town Park namely 'Puca Spooka' advising the Playground equipment would be closed to facilitate the setup from Thursday 28th to Sunday 1st November. The members welcomed the initiative and congratulated those involved in recent event in O'Connor Sq. noting these events are vital for the vitality of the town.
