## <u>APPLICATION FOR A FURTHER EXTENSION OF APPROPRIATE PERIOD</u> (Fee €62):

Applications to further extend the appropriate period by such additional period not exceeding **31st December 2023** may be made to the Planning Authority provided that:

- (a) The development was commenced and substantial works were carried out before the expiry of the duration or extended duration of the planning permission.
- (b) A further extension of duration is required to enable the development to be completed.
- (c) An Environmental Impact Assessment (EIA) and Appropriate Assessment (AA) are not required for the proposed extension.
- (d) The application for a further extension is in accordance with Section 42(B) of the Planning & Development Act 2000 (as amended).
