**TULLAMORE TOWN – CONSTRUCTION PARKING PERMIT - CONDITIONS**

In order to facilitate construction works on premises in pay and display areas in one hour or two hour maximum areas, a contractor may apply for permit to remain in such areas. Such permit will apply to a single goods vehicle and shall be for a duration of one week only. This permit has a weekly fee, which is subject to change within the Bye-Laws. The Scale of Charges and the periods to which they apply shall be as determined from time to time by resolution by the Council.

A Construction Parking Permit does not authorise parking in a prohibited manner or place. A Construction Parking Permit is only valid for the vehicle and the appropriate designated one and two hour max parking areas.

1. A copy only of the Vehicle Registration Certificate should accompany the application. Please do not send an original.
