Notice is hereby given that Offaly County Council proposes to carry out development at Tinamuck West, Tubber, County Offaly. The development will consist of:

The construction of a single storey extension (area 45.3m²) to the west side of an existing dwelling, external accessible access ramp and railings to the rear, replacement of existing rear patio door with window, provision of new rear door and all associated site development works.

The development has been the subject of an Appropriate Assessment screening in accordance with the EU Habitats Directive & the Planning and Development Act 2000 as amended.
