In order to help us to keep our commitment, we expect that you:

We will not accept:

- The use of offensive, threatening or inappropriate language towards staff and/or members of the public
- The use of violence or the threat of violence towards staff and/or members of the public

The following behaviour will not be accepted in any of our facilities:

- Behaviour which is disruptive and interferes with the use and enjoyment of the facility by others
- Malicious damage to and/or theft of Offaly County Council property
- The use of alcohol and illicit drugs
- Smoking and vaping, unless in designated areas
- Littering
- Photography, filming, recording, or livestreaming without permission
- Personal property being left unattended while using Offaly County Council facilities

Children should be supervised at all times while using our facilities.

Those under 18 not adhering to the Code of Conduct may not attend the library unless accompanied by a parent or guardian.

Ní ghlacfaimid le:

- Teanga gháirsiúil, bhagrach nó mhíchuí i leith na fairne agus/nó i leith an phobail
- Foréigean nó bagaírt foréigin i leith na fairne agus/nó i leith an phobail

Ní ghlacfar leis an iompar seo a leanas in aon cheann dár n-áiseanna:

- iompar a chuireann isteach ar dhaoine agus iad ag baint úsáid agus taitneamh as an áis
- Damáiste mailíseach do mhaoin Chomhairle Contae Uíbh Fhaillí agus/nó goid maoine
- Úsáid alcóil agus drugaí aindleathacha
- Caitheamh tobac nó galloitíní, seachas i limistéir shainithe
- Caitheamh bruscair
- Grianghráfodóireacht, scannánaíocht, beoshruthú, nó taifeadadh gan chead
- Maoin pearsanta a fhágáil gan aon duine a bheith ina bun a fhad is atá úsáid á baint as áiseanna Chomhairle Contae Uíbh Fhaillí
