### 3. Environment & Water Services Update – Mark Maken Finlay

Mark Maken Finlay, Authorised Officer, Environment & Water Services gave an update on the Environment/Water Services section covering the following areas/topics:

- Climate Action
- Environmental Management/Environmental Awareness
- Historical Landfills/Civic Amenity Sites
- Anti-Dumping Initiative 2023
- Burial Grounds
- Rural Water Programme
- Control of Dogs/Horses
- Veterinary Inspections

The Members thanked Mr. Finlay for his very comprehensive report. All queries raised in relation to this presentation were addressed by Mr. Finlay. District Director Sharon Kennedy requested that an engineer attend a future MD meeting in relation to the flow of rain water and sewage together and the resulting issues this creates.

### 4. GMA Applications

No applications were received for consideration by the Members for the July meeting.

### 5. Regeneration/Project Updates

District Director Sharon Kennedy confirmed that final design stage has almost been reached before proceeding to the Part 8, the process is going very well and anticipates it will reach the planning process in autumn. Ms. Kennedy acknowledged that it is a very lengthy process and hopes that aside from the functionality of the project, it will also be a feature of beauty for the town.

District Engineer Mark Mahon confirmed that a contractor has been identified for the Clonbullogue TVR, having met with the Tidy Towns members all is in order to proceed. The Portarlington TVR has been tendered, a contractor identified and Mr. Mahon will give a further update on this in due course.



### 6. Area Issues/Updates/Roads Update

District Engineer Mark Mahon outlined the following relating to the roads programme and area update:

- Road Reconstruction Works/Contracts Status
- Surface Dressing Works 80% complete at present
- Road Recycling Works 70% complete at present
- LIS Schemes Round 1 of LIS Schemes 2023 set to commence in mid-July
- CIR Schemes Rhode Grand Canal Footpath, Garryhinch Footpath Link, Walsh Island Footpath Link
- 2023 Bridge Works Boyne Bridge, Ballycommon Bridge, Killeen Bridge. Deadline for tender submissions today, July 12<sup>th</sup>.
- Safety Improvement Works 2023 Dereen and Sranure, Cloneygowan and Walsh Island Village Traffic Calming
- Edenderry MD ORIS Scheme Botley Lane, Portarlington. A joint initiative with Laois Co Co to provide a safe walking route from Town Centre to Derryounce Woods amenity.
- Ballyfore Vehicle Activated Signs: option of static signs or driver feedback signs
- Phase 2 of Inner Relief Road works commenced on site at the end of June, Tower Civil Engineering carrying out the works with project expected to reach completion by the end of March 2024.
- R402 Dublin Road/Hare's Lane Junction traffic lights due for installation next week
- Upgraded bus stop on JKL Street funded by the NTA, administered by Active Travel, scheduled to take 2-3 weeks to complete works.
- Proposed pedestrian crossing repainting on JKL Street scheduled for 19<sup>th</sup> July
- New 'Edenderry' Sign installed O'Connell Square
